This rule establishes the requirements for disseminating LEADS throughput and expectations for LEADS related record keeping. Proposed amendments add "access" to paragraph (A); remove unnecessary language from paragraph (B); remove paragraph (K); add "and maintenance of training" to paragraph (N)(1); reword paragraphs (N2) and (N3) for clarification; remove "device operators and "mobile service provider" from from paragraph (N)(5) and add "agency TAC" to paragraph (N)(5).
