This rule entitled "Local organizations" sets forth that each political subdivision

create a local capability for emergency management by participation in a countywide agency, a regional authority, by contract with a county or by forming a local political subdivision program. It also provides that a county may meet the requirements of R.C. 5502.271 by contracting with the chief executives of each participating political subdivision pursuant to R.C. 307.15.
