This filing is based on a R.C. 119.032, five-year review of rule 4501:3-4-01 of the Ohio Administrative Code. This new amended version of the rule is being proposed for adoption and simultaneously an existing rule (same title and number) is being proposed for rescission.

This rule entitled "Emergency management funding" provides requirements for the executive director of the Ohio emergency management agency and each local emergency management agency with regard to federal and state funding in support of local emergency management agencies. A proposed change updates the rule by deleting reference to "The Robert T. Stafford Disaster Relief and Emergency Assistance Act" which is no longer the statutory authority for federal emergency management funding. For language consistency within the rule, the proposed new version of the rule removes "will" and replaces it with "shall," and removes "emergency management" and replaces it with "Ohio Emergency management agency."
