**Requirements for embalmer's license.****(A) Registration Certification**

- (1) The applicant for an embalmer's registration certification shall apply to the board on a form provided by the board for registration certification, together with the applicable fee prior to the commencement of an apprenticeship.
- (2) The applicant shall provide an official college transcript, showing that the applicant has earned a bachelor's degree from a college or university authorized to confer degrees by the Ohio board of regents or comparable agency of another state in which the college or university is located, and an official college of mortuary science transcript, showing that the applicant has completed at least twelve months of instruction in a prescribed course of instruction approved by the board.
- (3) The applicant for registration certification shall provide and bear the cost of a criminal records check in accordance with section 4776.01 of the Revised Code at the time of the requested registration certification. The applicant shall establish that the individual has not been convicted of, pleaded guilty to, or had a judicial finding of eligibility for treatment in lieu of conviction for any offense set forth in section 4717.05 of the Revised Code, or that at least five years has elapsed since the applicant was released from incarceration, a community control sanction, a post-release control sanction, parole, or treatment in connection with such offense.
  - (a) An applicant requesting a criminal records check shall provide the bureau of criminal identification and investigation with the applicant's name and address and with the name and address of the board.
  - (b) The applicant shall ask the superintendent of the Ohio bureau of criminal identification and investigation in the request to obtain from the federal bureau of investigation any information it has pertaining to the applicant.
  - (c) The board will only accept the results of a criminal records check that is submitted to the board directly by the Ohio bureau of criminal identification and investigation.
- (4) Upon approval of the application for registration certification, the board shall issue an embalmer's certificate of registration certification.

**(B) Apprenticeship**

- (1) Upon issuance of a certificate of ~~registration~~certification, the applicant shall submit a certificate of apprenticeship, along with the applicable fee, certifying the commencement of the embalmer's apprenticeship credit time. The embalmer's certificate of apprenticeship shall bear the signature and certification of both the apprentice and the master embalmer and shall be filed with the board no later than ten days after the beginning of any embalmer's apprenticeship credit time.
- (2) Upon approval of a certificate of apprenticeship, the board shall issue an apprenticeship card, carrying the beginning date of the embalmer's apprenticeship credit time. This card shall be carried by the embalmer apprentice at all times while engaged as an embalmer apprentice.
- (3) The applicant shall satisfactorily complete not less than twelve months of apprenticeship under the direction of an embalmer and which apprenticeship must be certified to the board according to its requirements. The apprenticeship shall be completed in no more than eighteen months from the date the apprenticeship commenced, unless the master embalmer and apprentice comply with paragraph (C)(2) of this rule. During the embalmer apprenticeship, the applicant must personally assist in the arterial embalming of at least twenty-five dead human bodies under the direct supervision of the master embalmer, and must complete the tasks listed on the "Embalmer Task List." If the board finds that the apprentice did not adequately complete one or more tasks on the "Embalmer Task List" or did not receive the necessary training during his or her apprenticeship, the board may set out ~~remedial~~remedial steps for the apprentice to undertake in order to complete his or her apprenticeship.
- (4) During the time of embalmer's apprenticeship, the apprentice shall file with the board progress case reports quarterly upon forms supplied by the board. Failure to comply shall be grounds for voidance or suspension of apprenticeship credit time by the board.
- (5) The apprentice shall report or respond to any licensed board member or board staff within thirty days after the first six months of apprenticeship credit time for a personal interview with a board member, and shall report to any licensed board member annually thereafter during any period of apprenticeship.
- (6) During the period of embalmer's apprenticeship, the master embalmer under whom the apprentice embalmer is certified shall file with the board quarterly master embalmer's reports on the apprentice's activities, including fulfillment of the tasks listed on the "Embalmer Task List."

(C) Termination of embalmer's apprenticeship

- (1) Upon completion of the full apprenticeship credit time, the applicant shall submit the following:
  - (a) The embalmer's termination of apprenticeship form bearing the signature and certification of both the apprentice and master embalmer to the dates of apprenticeship credit time. This termination of apprenticeship shall be filed with the board no later than thirty days after the completion of any period of apprenticeship;
  - (b) The certificate of ~~registration~~certification;
  - (c) The apprenticeship card.
- (2) In the event the apprenticeship is interrupted prior to the completion of the apprenticeship, the master embalmer and apprentice embalmer shall immediately notify the board of the interruption, and submit the embalmer's termination of apprenticeship form, and the embalmer's apprenticeship card.
- (3) Failure to submit the embalmer's termination of apprenticeship form upon interruption of an apprenticeship prior to the completion of such apprenticeship shall be grounds for voidance by the board of the apprentice credit time.

#### (D) Examinations

- (1) Upon approval of the termination of apprenticeship and completion of the full apprenticeship credit time, the applicant for an embalmer's license shall provide proof of ~~earning a seventy-five per cent or higher on each section of a nationally-recognized comprehensive examination~~passing the National Board Exam administered by The International Conference of Funeral Service Examining Boards and sit for the Ohio ~~laws~~Laws and ~~rules~~Rules examination.
- (2) Upon ~~earning a passing score of seventy-five per cent or higher on each section of a nationally-recognized comprehensive examination~~passing the National Board Exam administered by The International Conference of Funeral Service Examining Boards and the Ohio ~~laws~~Laws and ~~rules~~Rules examination, the applicant shall submit to the board an application for embalmer's license, along with the applicable fee.

#### (E) Initial license

At the board meeting following receipt of the completed application for embalmer's license and the applicable fee, the board may grant an embalmer's license.
