A master embalmer and a master funeral director with five years of experience as an embalmer or funeral director in the state of Ohio must successfully complete training approved by the board. Training may be obtained by attending and participating in an approved program.

A provider, organization or person which desires to obtain approval of a course, program or other continuing education activity shall obtain approval prior to the activity. A provider, organization or person shall submit to the board an application established by the board. The board shall approve or deny such a completed application.

B. Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

The rule imposes a cause of action for failure to comply with its terms by implication of section 4717.14(A)(3) of the Ohio Revised Code.

Example: A licensed embalmer certifies (starts supervising) an embalming apprenticeship prior to completing master embalmer training. The board may

require the embalmer to take corrective action for violating the provisions of section 4717-5-02 of the Admin. Code.
