The new version of this rule eliminates a list of the different licenses and

certificates issued by the board. Rather than include specific language that might become quickly outdated, the proposed language is more general and refers to "licenses and certificates." The actual processes for document and record management are not changed although certain issues are clarified. Also, terminology is revised to reflect more current language.
