Section 4723.489, ORC was added to set forth the conditions required for persons to be delegated this authority, including a requirement that the person "has successfully completed education based on a recognized body of knowledge concerning drug administration and demonstrates to the person's employer the knowledge, skills and ability to administer the drug safely."
