The Rule establishes criteria and standards for a licensed nurse to delegate tasks to an unlicensed person. Rule 4723-13-02(D)(1) is revised to update cross-references. Paragraph (E)(5) is revised to correct a typographical error. Paragraph (C) is revised to update a cross reference to a statute. Rule 4723-13-05(E)(6)(g) and (F)(2)(c) are revised to add clarification requested by interested parties. Members of the Ohio Nursing Collaboration (consisting of Ohio Family to Family, Ohio Department of Developmental Disabilities/DODD, Ohio Department of Medicaid, and family members) requested language to underscore that when delegating a nursing task, a licensed nurse shall consider the total number of delegated nursing tasks to be performed for an individual. This concept is consistent with Rule 4723-13-07(C)(2), which references the types and number of nursing tasks that will be delegated.
