This rule is being revised to provide greater clarification to board licensees and certificate holders, as well as to continuing education approvers and providers.

References to continuing education categories B, C, and D are eliminated since these designations are not currently used. The term "planning committee" is

eliminated as it is viewed as too prescriptive a definition for all types of continuing education activities. Definitions are added for "inservice program," "reactivate," and "reinstate." The definition of "reporting period" is expanded to include "renewal period" and to reference community health workers and certified medication aides in addition to nurses and dialysis technicians.
