In paragraph (A)(7), the language is modified to address continuing education

credit for the development of independent study continuing education programs, as well as for the development and presentation of more traditional seminar activities. For independent study, the licensee will be given the same number of contact hours as the individual completing the continuing education activity. For presentation-type continuing education programs, a licensee developing and presenting a program will get credit for the first time the program is conducted, and will be awarded the same number of contact hours as participants will receive for that portion of the program.
