This rule is being revised to provide greater clarification to board licensees and certificate holders, as well as to continuing education approvers and providers.

This rule is revised to use the more general references of "licensee" and "certificate holder" to allow for its application to nurses, dialysis technicians, community health workers, and medication aides. Paragraph (A)(8) is moved from current rule 4723-14-02.
