This rule is being revised to provide greater clarification to board licensees and certificate holders, as well as to continuing education approvers and providers.

This rule sets forth the process for initial approval as an OBN (continuing education) approver. The changes to this rule are largely grammatical. Language is

added in paragraph (D) to provide that the board reviews a summary of a completed application, rather than requiring the board to review the entire application file.
