The rule deals with renewal of a medication aide certificate. The website location of a required form has been cited in the rule. Paragraph (A)(1) has been rearranged. Various rule cite references have been updated. A provision has been added regarding waiver of late fees due to a certificate holder's spouse's service in the armed forces according to House Bill 490.
