The rationale for the Rule is to provide clarity to the medicate aides as to how to renew, reinstate or reactivate their certificate, or place a certificate on inactive status. The revision to the Rule is to remove the requirement in paragraph (D)

that medication aides upload documentation of continuing education to their online renewal application.

The forms referenced are representative samples, as the forms used by individuals are accessed using secure passwords necessary to file the form on the Ohio eLicense Center electronic database, and it is infeasible to attach forms containing security passwords and personal identifiers to public rule filings.

To renew the medication aide certificate a form with disclosure of information is required. Biennial renewal of a medication aide certificate is \$50.00 if the fee is paid before the late processing date or \$100.00 if paid after the late processing date (Rule 4723-27-10 OAC).
