The rule requires that programs apply to the Board for approval as a medication
aide training program. It sets forth information that must be included in a training program approval application and requires that an application be submitted with the program approval fee established in OAC 4723-27-10 [proposed]. To be approved, a medication aide training program must include a minimum of 120 clock hours of instruction, including not less than 80 hours in didactic and laboratory instruction, and not less than 40 hours of supervised clinical practice. The rule also addresses program administrator and instructor standards, clinical practice site standards, recordkeeping requirements, program evaluation requirements, internal policy standards, and the means of renewing a training program approval.
