The Board seeks to to clarify that in order to hold a current, valid license for purposes of faculty/preceptor qualifications, an individual should not be currently subject to remaining terms or conditions of a consent agreement or Board order, e.g., whether in the form of a reprimand with an unpaid fine or probation with unfulfilled continuing education. The language regarding #for which the individual continues to meet all the requirements for issuance# is removed as superfluous. The language regarding the definition in effect from February 1, 2007 to February 1, 2008 is removed as obsolete.
