This rule establishes the qualifications for administrators, faculty, teaching assistants, and preceptors for practical nursing education programs. The rule is

promulgated as a new rule so as to reverse the order of paragraphs (A) and (B). In the current rule, paragraph (A) addresses qualifications for program administrators, faculty, and instructional personnel hired after September 1, 1971 and before April 2, 1996; paragraph (B) applies to hires on or after September 2, 1996. In the new rule, the order is reversed so that the current requirements appear first.

In paragraph (A)(2), reference to "associate or assistant administrators" is changed to "associate administrators" to standardize use of the term. In paragraph (A)(5)(c), language is revised to eliminate reference to "specialty certification" and require a demonstration of competence in a practice area rather than a demonstration of expertise. The latter standard is felt to be difficult to define and to establish.

The term "registered nursing" is substituted for "professional nursing."
