This rule is being amended to allow foreign educated personnel to serve in administrative, faculty or instructive capacity in a licensed practical nursing education program if they meet all other requirements and have been a practicing as a registered nurse in Ohio for at least two years.

Language has been added to allow an individual who is foreign educated, and thus has not completed a nursing education program located in a "jurisdiction" (i.e., a program approved by a member of the National Council of State Boards of Nursing), to serve in an administrative, faculty or instructive capacity if the individual meets all of the other requirements and has practiced nursing as a registered nurse in Ohio for at least two years.
