The rule establishes curriculum criteria for a registered nursing education program. The rule makes various technical changes for clarification. The rule revises requirements for clinical course study to permit high fidelity or mid or moderate fidelity simulation to replace specified clinical instruction requirements in obstetrical/immediate newborn care and pediatrics when conducted within the requirements of chapter 4723-5 rules governing program instruction and administration. Language has been added requiring humanities, social and behavioral sciences instruction necessary to include human sexuality and gender identity. The rule is also being revised to establish parameters for conducting simulation, including the use of computer technology specialists in operating computer equipment.
