This rule addresses the further requirements for licensure by examination for applicants who graduate from foreign nursing education programs. This is a restatement of the current requirements. Specifically these applicants must obtain a comprehensive nursing program evaluation that allows the board to compare their education to the requirements for nursing education programs in Ohio. Also, with the exception of graduates from programs in English speaking countries, these graduates must pass the Test of English as a Foreign Language.

Revisions are proposed to consolidate all provisions related to licensure for foreign educated nurse graduates, whether by examination or endorsement, under one rule. The rule is revised so that paragraph (A) addresses the requirements for foreign educated nurse graduates seeking licensure by examination. To the extent that the requirements are the same as for others applying to take the licensure exam, the rule incorporates the provisions in rules 4723-7-02 and 4723-7-03. Paragraph (B) is rewritten to address the requirements for foreign educated nurse graduates seeking licensure by endorsement. These requirements are largely unchanged from the

current rules, but revised for clarity.
