The rule deals with registered nurse licensure by endorsement. Language is added to reflect change made by House Bill 303 regarding sex offender status, and completion of two hours of Category A (Ohio Law and Rules) continuing education. Language is added to allow verification of licensure electronically from the National Council of State Boards of Nursing. The website location of a required form has been cited in the rule.
