The Rule provides requirements for a volunteer's certificate. Paragraph (B) is revised to add language clarifying that the RN or APRN applicant complete CE in the RN scope, and the PN applicant complete CE in the PN scope.

Additionally, forms contain data (e.g., calendar dates, references to statutes) that are updated from time to time, and it is infeasible, and not a good use of state resources, to file new rules and hold public rule hearings, each time changes are made to forms. The forms referenced are representative samples, as the forms used by individuals are accessed using secure passwords necessary to file the form on the Ohio eLicense Center electronic database, and it is infeasible to attach forms containing security passwords and personal identifiers to public rule filings.
