Page 2 Rule Number: 4723-7-10

This rule is proposed to mirror the requirements in Section 4723.26, ORC, for obtaining a Volunteer's Certificate (H.B. 320, 130th GA). No fee is required for this certificate. The Rule would require that when working in this capacity, the nurse display credentials showing the Volunteer's Certificate status and document that status in nursing documentation. The rule clarifies that the status can be abbreviated in nursing documentation as "V.C."
