The rule is proposed to make terminology changes in accordance with recently passed HB 216 of the 131st General Assembly.

The rule governs standard care arrangements for advanced practice registered nurses and their collaborating physicians. The rule has been revised to reflect changes in terminology following HB 216. Rule revises language regarding CNS who specializes in mental health to reflect HB 216 changes which require the CNS to have a collaborating agreement with a physician whose specialty is the same or similar, or is in pediatrics, or in primary care or family care. Revise to reflect that employer retains copy of SCA per HB 216. Added language to note the exception to the 30-day time frame regarding physician termination in 4723.431(E), as adopted in HB 216.
