The rule establishes quality assurance standards for APRN practice. Paragraph (D) (1) (renumbered C) is revised because this rule provides standards for standard care arrangements, and the "supervising" language and "dentist" language relates to CRNAs, who do not have standard care arrangements. Additionally, OAAPN recommended deletion of requirements perceived as unnecessary and burdensome.

The rule establishes quality assurance standards of practice for APRNs, and grounds for disciplinary action if standards are not met. Sanctions for violation of Chapter 4723., ORC or Chapter 4723-8, OAC may include fines, license restrictions, suspension or revocation.

The rule cross references statutes that require completion of continuing education and maintenance of national certification in order for the APRN license to be maintained.
