This rule is being filed pursuant to the five-year rule review process required by Ohio Revised Code (ORC) Section 119.032.

The rule establishes quality assurance standards for collaborative practice. Paragraph (F) is revised to clarify that online verification through the Ohio eLicense website is sufficient and removes requirement that the APRN "verify certification" of the collaborator; although a physician may be "certified" in a specialty, APRN certification is not predicated on the physician's certification, rather it is dependent on the physician or other collaborator's "licensure" and being in the "same or similar" practice. In (G), the word "audit" is added.
