References to certified nurse midwife, certified nurse practitioner, certified

registered nurse practitioner, and clinical nurse specialist are changed to advanced practice nurse where appropriate. Changes are made to establish consistent use of the terms "reactivate" for inactive certificates, and "reinstate" for lapsed certificates. Paragraph (F) is deleted because it is confusing and redundant. Paragraph (J) is revised to be consistent with other chapters and to be more clear on the manner in which a certificate may be placed on inactive status. Specific fee amounts are deleted and the reference is changed to "applicable" fee. The amount specified in current rule is no longer correct. The amount of the fee has been decreased. Paragraph (K) is existing rule language that is promoted to an individual, designated paragraph.
