The rule deals with certificate of authority renewal and notification of national recertification. Obsolete language is being deleted as the Board is adopting new rules to consolidate references to fee waivers available to service members, veterans, and their spouses.

The Board relocated information previously addressed in multiple sections of Chapter 4723 of the Ohio Administrative Code (OAC), to a single chapter. By placing information specific to military service members and their spouses in the Chapter 4723-2, OAC, the Board intends to help service members and their spouses more easily identify and utilize these provisions. As the rule reflects pre-existing fee waiver benefits, the Board anticipates no net impact on revenues or expenditures.
