The rule is proposed to make terminology changes in accordance with recently passed HB 216 and HB 290 of the 131st General Assembly.

The rule establishes continuing education requirements for advanced practice registered nurses. The rule revisions add language to include new requirements for

APRN CE imposed by HB 216; add language providing that for first renewal period, no CE is required; adds language to include volunteer service credit for up to eight hours of CE, implemented by HB 290 of the 131st General Assembly; adds language to prohibit CE carryover; adds language indicating first-time licensure CE waiver that applies to new RN/PN license does not apply.
