The rule summarizes requirements for a course of study in advanced pharmacology. Rule 9-02(A): Requirements and references in (2)(b), (c), and (d) that applicants obtain six hours of instruction in specific areas and six hours of instruction specific to schedule II controlled substances have been deleted. The law (4723.482(B), ORC) requires instruction in fiscal and ethical considerations, and schedule II controlled substances, as part of the 45-hour course in advanced pharmacology, but does not impose minimum hours in these topics. The six-hour minimum was added when SB 83 (129th GA) authorized CTP holders to prescribe schedule II controlled substances (SB 83 required all CTP holders to take six hours in schedule II instruction as a condition of certificate renewal). Language is added in (A)(2)(e) to clarify that the schedule II content area can be presented in an integrated manner with the other areas of instruction.
