The rule deals with standards and procedures for obtaining an externship certificate to prescribe. The website location of a required form has been cited in the rule. Language requiring physician documentation is deleted according to changes made by House Bill 303, and the externship certificate to prescribe extension has been changed from one year, to two years, as this was changed by House Bill 303.
