The rule defines such terms as "cross-coverage," "BMI, "acute pain," and "morphine equivalent daily dose." It is amended by a clarification to the definition of "acute

pain," and the addition of definitions of "medication therapy mananagement," subacute pain," and "chronic pain." The additional terms are used in new rule 4731-11-14. Moreover, "chronic pain," was formerly defined in rule 4731-21-01 of the Administrative Code.

08/28/2018 The rule is revised at paragraph (L) by adding the language that clarifies that acute pain does not last more than six weeks in duration. This phrase was inadvertently omitted from the rule body that was originally filed.
