That section requires the Medical Board to adopt rules setting requirements for physicians who wish to provide a prescription drug to a patient the physician has not physically examined. The amendments to the rule define terms

that are used in new rule 4731-11-09, consistent with the provisions of Section 4731.74 of the Revised Code.

The amendments add the definitions of "cross coverage" and "active patient." The definition of "opioid treatment program" is deleted as it is not used in any of the rules in Chapter 4731-11.
