The rule specifies the general provisions of a veterinary business facility license which is issued to a veterinary business facility not fully owned by a currently licensed veterinarian. The change would correct an oversight when the rule was initially implemented. The rule should mirror the state law that permits the Board to refuse to issue a license for the specified violations. The amended rule would correct that. The other change is to delete the term "knowing" for a violation of Chapter 4741 of the Revised Code. The burden of proving a "knowing" violation is too onerous. The change would mirror the current state law of Section 4741.22 ORC.

A veterinary business facility not fully owned by a currently licensed veterinarian, must meet the requirements of Section 4741.28 of the Revised Code to obtain a veterinary business facility license in order to provide veterinary medical services in the State of Ohio.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

A veterinary business facility must meet and comply with all requirements as set forth in section 4741.28 ORC and rules adopted, and any other applicable state or federal laws and rules. Failure to meet and maintain these requirements shall be considered noncompliance and may affect the facility's licensure status. The violations listed mirror those of Section 4741.22 ORC which apply to veterinarians and registered veterinary technicians.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

The Veterinary Business facility license can be obtained at the initial cost of \$300 and biennial renewal fee of \$300. There are no late penalties assessed for renewing late for the Veterinary Business Facility license.
