Persons wishing to obtain Ohio hearing aid licensure must complete an educational program that meets the curriculum requirements set forth in O.A.C. Rule 4747-01-19. The cost of obtaining the education in Ohio depends upon the method the student completes to meet the minimum educational requirements for Ohio licensure.

Information gathered found that current tuition purchased from a private sector training program is \$279 to \$299 for the trainee program and from \$849 to \$949 for a distance learning course. The fee for the international licensing exam is \$250, none of which is paid to the Board. The licensure application fee is \$262 (See ORC Section 4747.05), with a \$157 renewal fee (See ORC Section 4747.06). The adverse impact for licensure programs is the cost incurred to develop and maintain courses that meet the minimum curriculum requirements and develop materials to provide required information to students. There is no reliable information upon which a monetary amount can be based.
