This rule sets forth requirements for the holder of a hearing aid dealer and fitter's trainee permit. The supervisor of a trainee must be physically present during the

fitting or selling of hearing aids for ninety days after the trainee permit is issued. Also, to supervise a trainee, a person must have been licensed for at least two years, and supervise only one trainee at a time.

The rule is proposed with no change.
