Page 2 Rule Number: 4751-1-07

O.A.C. 4751-1-07, requires applicants for nursing home administrator's licenses to pass an examination. Additionally, the rule sets forth a framework the Board will use consistently in grading the exams. Finally the rule states that candidates who have failed the test three times are ineligible to sit for the exam again until they meet requirements set forth in rule 4751-1-05 and any additional education or experience requirements that may be prescribed by the board. The rule is amended to change the pronoun "he" to "the candidate."
