HB49 enacted ORC §§ 4751.043 and 4751.044, which authorized the Board to contract with other entities to establish training programs and to charge those entities with fees to compensate the Board for its work to review proposed courses in the Board's

approval process. Implementing these new sections require the Board to amend this rule.

Additionally, the Board has reviewed this rule top to bottom, and proposes to update the rule in other ways, which ORC§106.03 requires the Board to do no less often than every 5 years.

This rule regulates institutions and training agencies that apply to the Board to provide continuing education courses to licensed nursing home administrators.

The Board proposes to amend this in the following ways:

1. The Board proposes to add a fee structure for the institutions/agencies to pay to the Board for reviewing their courses to seek the Board's approval.

2. The Board proposes to more clearly define categories of continuing education training agencies. This includes deleting the "limited" provider status from this rule and increasing the years of experience an agency must have in offering continuing education courses before qualifying to be a preferred continuing education training agency from 1 year to 3 years.
