This rule exists to establish requirements for the Administrator-in-Training (AIT) Program.

## 8. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

This rule establishes the AIT Program.

The Board proposes to amend this rule to achieve the following:

- 1. Replace "fee transmittal sheet" with "fee invoice" in paragraph (C)(1)(a) of this rule.
- 2. Insert "form" after "AIT program" in paragraph (C)(1)(a) of this rule.
- 3. Replace "training plan" throughout this rule with "professional development plan."
- 4. Extend the application deadline in paragraph (C)(2) of this rule from 14 to 21 days.
- 5. Insert "and be deemed by the board to provide quality care in a safe environment" at the end of the first sentence in paragraph (D)(1)(c) of this rule.
- 6. Replace "asked" in paragraph (D)(1)(c) of this rule with "required."
- 7. Insert a new paragraph (D)(1)(d) of this rule on the requirements of out-of-state training sites.
- 8. Insert a new requirement to use the NAB professional development plan form into paragraph (E)(2) of this rule and indicate the website on which an applicant may find the form.
- 9. Insert new paragraph (E)(4) of this rule to require an AIT assessment form.
- 10. Insert new paragraph (F) of this rule on waivers against (flexibilities regarding) this rule's requirements. This new paragraph replaces paragraph (F)(5) in the current version of this rule.
- 11. Insert new paragraphs (G)(5) to (G)(12) of this rule to establish requirements (e.g., reporting) and parameters (e.g., vacation) for the AIT Program.
- 12. Insert a new second sentence to paragraph (H)(2)(b) of this rule that says, "If the AIT fails to file reports promptly, such trainee may be deemed to have abandoned the administrator-in-training program."

13. Insert a new paragraph (H)(2)(d) of this rule to require the AIT to maintain a daily log of training hours.

- 14. Insert a new paragraph (J)(5) of this rule after paragraph (J)(4) of this rule to indicate that an AIT cannot also serve as a nursing home's director of nursing.
- 15. Insert a new paragraph (J)(8) of this rule after paragraph (J)(7) of this rule to require AIT preceptors to participate in the Board's online training course for preceptors.
- 16. Remove occurrences of "or not" occurring after "whether" in paragraphs (J)(9)(a) to (J)(9)(c) of this rule.
- 17. Insert a new second sentence to paragraph (J)(10) of this rule to establish that a person may qualify to be an out-of-state preceptor only if the person has been a full-time LNHA for at least two years and currently has an active certificate of registration.
- 18. Insert new paragraphs (J)(11) to (J)(13) of this rule after paragraph (J)(10) of this rule to establish new requirements for preceptors to provide orientation, a list of requirements, and equipment to AITs.
- 19. Insert a new paragraph (K)(1) of this rule to establish the order of entities to which an AIT must file a grievance from facility supervisor, then to preceptor if not resolved by the supervisor, and then to the Board if necessary.
- 20. Insert a new paragraph (M) on the Core of Knowledge course.
- 21. To update the revision date for forms under paragraph (N) of this rule.
