This rule exists to establish the standards for the timely renewal of license registrations.

# 8. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

This rule establishes the standards for the timely renewal of license registrations.

The Board proposes to amend this rule to achieve the following:

- 1. Reflect H.B. 509's amendments to R.C. Chapter 4751, which replaced annual renewal of license (registration) with biennial renewal and doubled the renewal fee. This includes dividing licensees alphabetically into two groups with a phased-in plan for one group to have renewal deadlines on even-numbered years and the other to have renewal deadlines on odd-numbered years.
- 2. Replace the requirement for 20 hours of annual continuing education in paragraph (F)(2) of this rule with a requirement for 40 hours of biennial continuing education. This is in response to H.B. 509's changes noted in #1.
- 3. Replace the requirement for 4 hours of additional annual continuing education for HSEs in paragraph (F)(3) of this rule with a requirement for 8 additional hours of additional biennial continuing education for HSEs. This is in response to H.B. 509's changes noted in #1.
- 4. Require licensees (LNHAs and HSEs), in paragraph (F)(4) of this rule, to complete one continuing education course per renewal period on ethics or professional standards of practice.
- 5. Delete the parenthetical sentence in paragraph (F)(7) of this rule.
- 6. Delete the requirement in paragraph (F)(8) of this rule to notarize the attestation statement.
- 7. Update the reference to the paper-version of the renewal application in paragraph (G) of this rule.

The Board also proposes to make other non-substantive improvements to this rule.

Paragraph (H) of this rule requires licensees to pay a \$50/quarter (up to \$200) penalty fee for untimely renewals of licenses.

This rule requires licensees wanting to (1) renew their license to apply for renewal before the current license expires, (2) complete continuing education before applying, and (3) pay the renewal fee.
