For a licensee, the cost of compliance with this rule is renewing a license (registration) before it expires, applying for renewal, completing continuing education before applying, and paying the renewal fee. The Board's proposed amendment to this rule will reduce the cost of compliance by giving licensees flexibility to obtain all continuing

education hours by self-study/distance learning/online as long as those courses are approved by NAB or the Board.

This rule does not establish a requirement for licensure (cf. R.C. §4751.10). Instead, it establishes the standards for timely renewal (registration) of licenses.

Paragraph (H) of this rule requires licensees to pay a \$50/quarter (up to \$200) penalty fee for untimely renewals of licenses.

This rule requires licensees wanting to (1) renew their license to apply for renewal before the current license expires, (2) complete continuing education before applying, and (3) pay the renewal fee. As previously mentioned, the Board's proposed amendment to this rule will reduce the cost of compliance by giving licensees flexibility to obtain all continuing education hours by self-

study/distance learning/online as long as those courses are approved by NAB or the Board.
