The Board proposes to amend this rule to achieve the following:

- 1. Increase the age a person may qualify for a temporary license from 18 to 21 years of age.
- 2. Replace "4751.10" in (E) with "4751.32."

Additionally, the Board proposes to update the "rule amplifies" section of this rule to correspond to the renumbering of R.C. Chapter 4751. of the Revised Code by H.B. 166 (133rd G.A.).
