The Board proposes to amend this rule to achieve the following:

1. Add language to reflect the new licensure category of Health Services Executive.

2. Replace "shall revoke or suspend" with "may revoke or suspend or impose a civil penalty, fine, or other sanction authorized by the board" to increase flexibility when dealing with licensees and infractions of the disciplinary laws and rules.

3. Add language to reflect not keeping the examination content confidential and "substantial deviation" from the Board's Code of Ethics as disciplinary infractions.
