As of January 1, 2010, the examination registration fee is \$370 and the Prometric Testing Center sitting fee is \$70.60 for PT applicants and \$55.60 for PTA applicants. The Board estimates no more than 2 or 3 applicants each year that would be subject to the NPTE retake requirement.
