6. **What are the reasons for proposing the rule?**

To comply with law requiring certain volunteer work to count as continuing education and to implement a jurisprudence/ethics module to be taken as continuing education for physical therapists and physical therapist assistants.

7. Summarize the rule's content, and if this is an amended rule, also summarize the rule's changes.

This rule details the continuing education requirements that must be met to be in compliance with license renewal requirements every two years. The changes implement House Bill 290 from the 131st General Assembly, which permits licensees to provide volunteer services to an indigent and uninsured person in certain settings in order to fulfill a portion of their continuing education requirement. Another change adopts a "jurisprudence" test to be taken every two years, initially as an optional component of license renewal, and then a requirement. The jurisprudence activity tests a license holder's knowledge of current laws and rules. Another change allows specialty certifications to count toward continuing education.
