The amendment allows for continuing education credit for certain activities current being undertaken by licensees. Under the current process, the activities identified in the amendment must go through the Ohio Approval Number review process, which costs between \$25-40 per course. The amendment would eliminate the cost for review of the activity since the rule would state that these activities are automatically acceptable.
