There are two proposed changes to this rule. The first change adds the initials "CPT" and "cPT" to the list of initials and terms that may only be used by individuals licensed by the Board. This list of title protected terms and initials helps ensure that a consumer is not misled into believing that they are receiving services from a licensed physical therapist if that individual is not licensed by the Board. The second proposed change defines "telehealth" and clarifies that if a physical therapy patient is physically located in Ohio, the PT or PTA providing services via telehealth must hold an Ohio license, even if the PT or PTA are not physically located in Ohio.
