The passage of Am. Sub. H.B. 284 of the 129th G.A. added physician assistants to the list of individuals from whom a physical therapist may accept a referral. This bill, as well as S.B. 141 also modified the division of R.C. 4755.48 that is referenced in the rule. The revised filing updates the cross-reference. In addition, the revised filing clarifies that the two years of practical experience referenced in new paragraph (F) could have occurred in Ohio, in addition to in another state or U.S. territory.
