The Board will lose the \$20 application fee to place a license in escrow, assuming that once that option is eliminated, the license holder will simply make the license inactive (which requires no fee).

The cost of compliance with this rule is that a license holder pays \$20 to place a license in

escrow and \$80 to restore the license from escrow.

In the future, the recommended process would be to forfeit the escrow status, saving the

license holder the \$20 to renew the license in escrow (up to three times for \$60). The reinstatement fee would be \$100 instead of \$80. Essentially, this change is cost neutral from

a fee standpoint.
