The defines how licensees may use teletherapy in the practice of the Board's professions. The proposed changes include the use of the term "teletherapy", which is the commonly accepted term and reinforces that informed consent must be obtained

prior to delivering services. Additionally, the revisions clarify training expectations for licensees, indicating the training is not required but reinforcing that licensees must have the appropriate skills to provide services via teletherapy. The revisions include limited provisions adding flexibility for licensees to commence services without a face to face in-person or video meeting, allowing verbal consent, and directing licensees to consider guidance from the U.S. Department of Health and Human Services regarding HIPAA requirements. These provisions of the rule expire when the current COVID emergency ends.
